Men aged 18 – 25 are required to register with Selective Service. This requirement covers men residing in the United States who are U.S. citizens or noncitizens, except that a man who is in the U.S. as a lawful nonimmigrant isn't required to register as long as he maintains that status. The Department of Education requires male students, who would like to receive federal financial aid, to be registered with the Selective Service.

According to the results of your FAFSA, you have not registered for Selective Service. If you are between the ages of 18 – 25, you must register online at the Selective Service website (www.sss.gov) or by filling out a form available at a post office. You can also make a correction to your FAFSA application and ask to be registered through your FAFSA. Please wait three to five business days for the Financial Aid and Scholarships Office to receive your updated FAFSA.

If you failed to register, are not required to register, or are exempt from the requirement to register; you must complete this form. A man must register with Selective Service within 30 days of his 18th birthday; however, males who are not yet 18 at the time they complete their FAFSA are not required to be registered for that aid year for financial aid purposes, but will be required to be registered for the following year. Males born before 1960 are not required to register.

Undocumented males must register with Selective Service. You can register at any U.S. Post Office and do not need a social security number.

Only persons assigned the sex of male at birth are required to register. If a student's gender identity is now female but she was assigned the sex of male at birth, the student must register with Selective Service unless one of the exemptions described in this document apply, regardless of the subsequent sexual reassignment surgery or any other gender transition process. If a student's gender identity is now male but he was assigned the sex of female at birth, the student is not required to register with Selective Service, regardless of the subsequent sexual reassignment surgery or any other gender transition process.

If you are female, and incorrectly stated you are a male or left the gender question blank, return to your FAFSA application and update the gender question to "Female". Please wait three to five business days for the Financial Aid and Scholarships Office to receive your updated FAFSA.

Review the following information, select the circumstance that pertains to your situation, sign and send in a copy via email, fax or mail to the University Office of Scholarships and Financial Aid.

## If you have a Status Information Letter from Selective Service stating you were not required to register, you may submit it as it as documentation proving your exempt status.
